

**PANAMA CANAL SOCIETY, INC.  
GENERAL MEMBERSHIP MEETING  
TOM STATHAM PARK, TITUSVILLE, FLORIDA  
NOVEMBER 9, 2009**

**President Tom Wilder** welcomed the 77 members and guests in attendance to the General Membership Meeting held at Tom Statham Park, Titusville, Florida on November 9, 2009 and called the meeting to order at 12:30 p.m.

In the absence of **Cheryl Russell**, **Tom Wilder** gave the invocation and in the absence of **Chris Wilder**, **Margaret McLaughlin** led the membership in the Pledge of Allegiance.

**President Tom Wilder** recognized past president Bill McLaughlin who was in attendance and introduced the board members who were in attendance including Margaret McLaughlin, 1<sup>st</sup> Vice President; Pam Reid, Director; Bill McLaughlin, Bylaws Chairperson and 2010 Reunion Coordinator; and Nancy Van Sclen, Office Manager.
