

**PANAMA CANAL SOCIETY, INC.  
GENERAL MEMBERSHIP MEETING  
OCALA ELKS LODGE, OCALA FLORIDA  
SEPTEMBER 12, 2009**

**President Tom Wilder** welcomed the 52 members and guests in attendance to the General Membership Meeting held at the Ocala Elks Lodge, Ocala, Florida on September 12, 2009 and called the meeting to order at 11:55 a.m.
